10 Italian's Company (or Organization) Letter

Letter from company or organization must contain the following information: Download the official sample model to be signed by the inviting Italian Compagny. From our Application section

11 Chamber of Commerce

Italian Chamber of Commerce Registration for Italian Company inviting "VISURA CAMERALE". Not needed for members of TV, Radio, film crews, Journalists and Correspondents

6 Proof of Accommodation for transit

The following is accepted:

Confirmed hotel bookings. At last 60% of the stay should be booked in Italy. For maritime workers : see documents in OOS code

7 Owner of ship (only for maritime workers)

Ship Owners or Duly Authorized Ship Agent to provide maritime workers with confirm that they (Ship Owners) will be responsible for the maritime workers, should they be disembarked for any reason:

- •State position on board of the cruise liner
- •Copy of maritime workers' contract
- Copy of vessels registration papers
- •Intended itinerary for cruising season that shows that Italy is the main destination
- Port letter with Port Authority stamp, confirming vessel on route/docked
