APPLICATION FOR A VISA

Important Instructions and Information

(Please read carefully)

PURPOSE OF A VISA

A visa only enables the holder to proceed to a port of entry before or on the expiry date of the visa, where the holder must comply with the applicable law, regulations and the following entry requirements of the Republic of Bolivia. Ten (10) days must be allowed for the processing thereof.

ENTRY REQUIREMENTS

- An acceptable passport/travel document to be valid for no less than 30 days after the expiry of the intended stay and containing at least two blank pages for endorsements.
- A valid visa.
- Sufficient funds preferably in US\$ dollars, also Euros are accepted in selected Foreign Exchange Offices.
- A return/onward ticket.
- Yellow fever certificates are required if the journey starts or entails passing through the yellow fever belt of Africa or South America.

WHERE TO APPLY FOR A VISA

- At the Bolivian Consulate in Johannesburg for all South African Residents. (Applicant's country of normal residence).

WHAT TO SUBMIT

- Valid Passport
- Visa Application Form
- 1 recent photograph (passport size)
- Proof of booking of airline ticket or confirmed itinerary.
- Prescribed Visa Fee (US\$ 30) or the equivalent in Rands (please phone the Consulate to get the latest exchange rate +/-R350.-) for a single entry (Fees are levied per application and are not refundable should the application be refused). No multiple visas are issued.
- Photocopy of Yellow Fever Certificate
- Photocopy of the passport page, which shows the photograph.

DURATION AND PURPOSE OF STAY

- The period of duration of the tourist visa will be determined from the applicant's date of admission into the Republic of Bolivia in accordance with any conditions that may appear on the actual visa. On admission, the visa will be deemed to be a visitor's permit for **30** days.
